

Guidelines for Nominations to the No5G Party Committee

The current No5G Party Committee would like to thank you for your nomination to fulfil a position on the Committee for the next annual term.

There are 10 Committee Members positions up for election.

- President
- Vice President
- Treasurer
- Secretary
- Public Officer
- 5 Ordinary Committee Members

Please read and adhere to the following guidelines when completing your nomination.

1. NOMINATION:

1. In line with Clause 16 **Election of committee members** (1) Nominations of candidates for election as office-bearers or ordinary committee members:
 - a) must be made in writing, signed by 2 members of the association and accompanied by the written consent of the candidate (which may be endorsed on the form of the nomination); and
 - b) must be delivered to the **Secretary at least 7 days before the date fixed for the holding of the annual general meeting at which the election is to take place**. Nominations may be sent to admin@no5gparty.org.au.

2. BIOGRAPHY:

Nominee biographies must be short and concise with a **maximum of 500 words**. Please ensure your biography has been spell checked and contains all relevant information.

PLEASE NOTE: Your biography will not be rewritten, edited or modified in any way. The information you provide in your biography will be copied and pasted and posted on the website for members to access. Members will be notified of all nominations.

3. PHOTOGRAPH:

It is the responsibility of the nominee to provide a photograph to accompany the biography.

4. CAMPAIGN WRITE-UP

In addition to providing a biography, nominees may also provide a campaign write-up in which they explain their goals, purpose in running and why members should award them their vote. Campaign write-ups must be short and concise with a **maximum of 500 words**.

5. NOMINATIONS WILL BE PUBLISHED ON THE WEBSITE:

The biography, photo and campaign write-up of each nominee as provided to the Secretary, will be published on the website before **31 March 2025**, being the date of the annual general meeting at which this election will take place.

Please be aware that the biography, photo and campaign write-up you send to the Secretary, will be published on the member area on the website without any editing.

5. CONSTITUTION OF NO5G INC.

Nominees are required to read the rules of the No5G Inc Association in the [Constitution](#). More information about what we do and the [current committee members](#) can be found under [About](#) on the website.

6. EXPECTATIONS OF THOSE WHO FILL A POSITION ON THE COMMITTEE:

It is expected that an ordinary committee member will voluntarily give 2 to 4 hours per week to check emails and work on any tasks assigned to them at a committee meeting. Office-bearers may be required to give significantly more time.

Committee meetings are held fortnightly and are typically 1-2 hours. It is expected that all committee members will attend every meeting and give apologies when unable to attend.

There may be other expectations that are not listed here, depending on the unique make-up of the elected Committee.

Subject to the constitution and their agreement, Committee members are to hold office until the conclusion of their annual term. All serving Committee members shall retire at the end of their term but are eligible for re-election at the next annual general meeting. There is no maximum number of consecutive terms for which a committee member may hold office.

7. ELIGIBILITY:

A person nominated as a candidate for election as a committee member must be a registered member of the No5G Inc (also known as the No5G Party) and must have been a continuing member of the association for at least three months before the date of the annual general meeting.
